Note: There will be ice available to help keep your beer cold. You must provide your own tubs or bins.

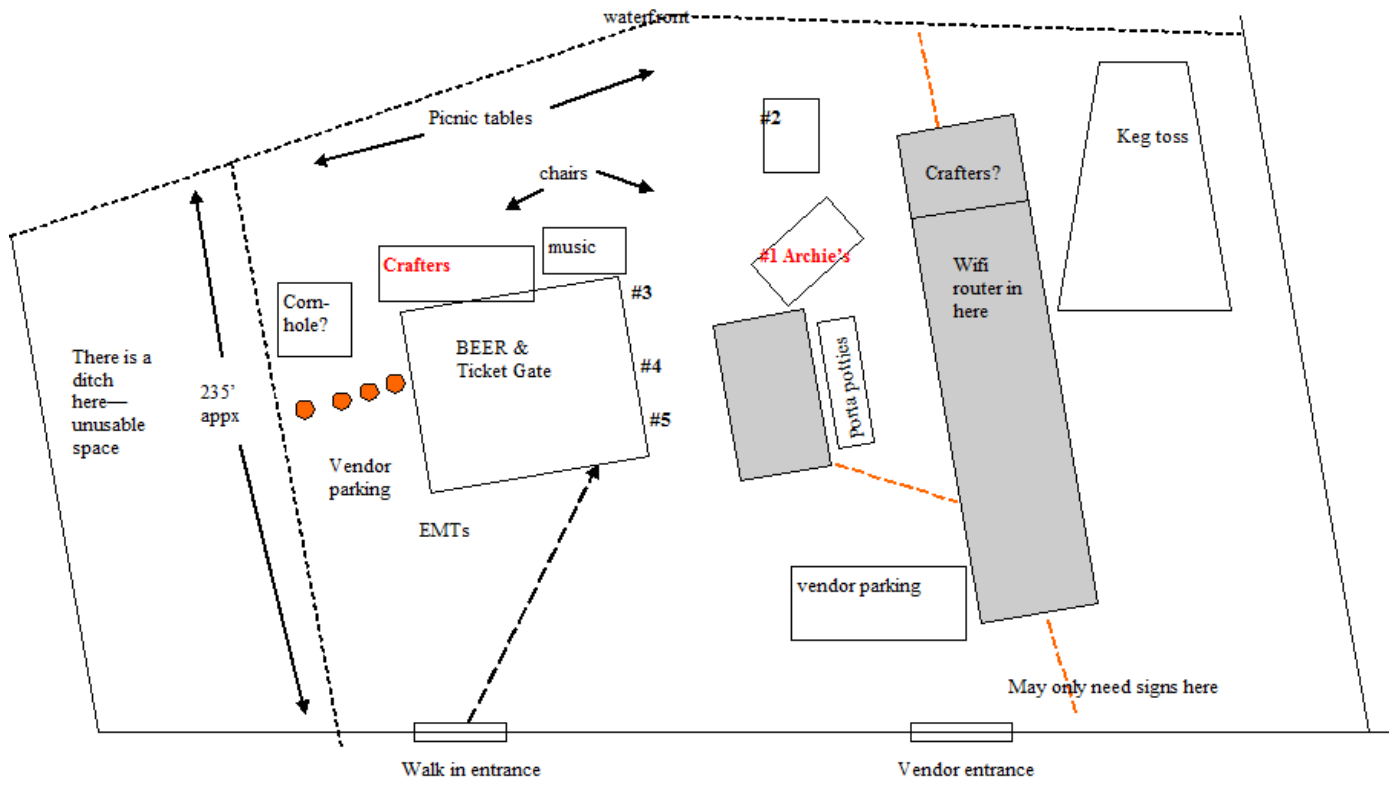
Conditions of Agreement

- Acadia Chamber will file for the required Special Taste Testing Event Liquor License on behalf of the brewers.
- Acadia Chamber will provide server badges as required by law.
- Insurance and personal security are the responsibility of the vendor. Please send us a copy of your insurance certificate with this form.
- **Pourers may not drink while serving beer. No one who is visibly drunk shall be served.**
- Acadia Chamber retains the right to issue additional rules on the day of the event.
